CARES ACT: UTILIZATION REPORT OF RELIEF FUNDS EMERGENCY FINANCIAL FOR STUDENTS (OCTOBER 1 THROUGH DECEMBER 31, 2021)

The Universidad Central de Bayamón (UCB) notifies the institutional community that it has signed and filed an agreement with the Federal Department of Education (DoE) on April 14, 2020, where it is established that you will receive financial aid for the institution for students. At the moment, the amount received is \$9,837,588, of which \$4,187,426 of funds received under Section 18004(a)(1) of the CARES Act are intended to be awarded to students, in the form of funds of emergency financial assistance as provided by the agreement.

For such purposes, 90 days after signing this agreement, the institution received the amount of \$479,227, earmarked for the use of emergency financial assistance for students. In addition, on January 17, 2021, he received an allocation of \$479,227 and on May 25, 2021, he received \$3,228,972.

So far, the amount of \$2,658,499 has been disbursed to those students who completed the Acceptance and Commitment Form for the granting of funds. Therefore, as of the date of this report, UCB has impacted 1,581 undergraduate and graduate level students with aid funds CARES Act emergency funding.

- In the period from March to June 2020, 782 students were impacted.
- In the period from August to December 2020, 340 students were impacted.
- In the period from January to June 2021, 915 students were impacted.
- In the period from October to December 2021, 911 students were impacted.

UCB determined the eligibility, selection, and process for assigning and distributing funds, according to the institutional procedure for the granting of CARES Act funds for students, institutional procedure designed for these purposes. The it was reviewed and updated according to

changes in the guidelines and requirements established for the award of funds HEERF CARES Act (<https://govinfo.gov/content/pkg/FR-2020-06-17/pdf/2020-12965.pdf>) of June 17, 2020.

The students received an institutional communication informing them about the allocation of these funds and the eligibility process for them (see Annexes).

RE: DISTRIBUTION OF EMERGENCY FUND FOR POST-SECONDARY EDUCATIONAL INSTITUTIONS UNDER THE AMERICAN RESCUE PLAN ACT (ARP)

Greetings from the Universidad Central de Bayamón (UCB)!

UCB received the new allocation of emergency assistance funds for eligible students from Higher Education Institutions, Higher Education Emergency Relief Fund (HEERF III), American Rescue Plan (ARP) Act. The Federal Department of Education announced the final rule of eligibility to receive these emergency financial aid grants for students under HEERF III, 86 FR 26608. In it the term student is defined for HEERF programs as any person who is enrolled in an eligible institution, as defined in 34 CFR § 668.2 and 34 CFR § 600.2, on or after March 13, 2020, date of the declaration of the national emergency due to coronavirus (85 FR 15337). Therefore, the students are no longer required to be Title IV eligible to receive aid under HEERF III of the ARP Act. Students eligible to receive this aid are:

- Active students who are enrolled in a degree or certificate program at UCB, regardless of whether they completed a FAFSA aid application or are eligible for Title IV.
- Must be US citizens, permanent residents, refugees, asylum seekers, Deferred Action for Childhood Arrival Recipients (DACA), other DREAMers or undocumented.

Given these conditions, students eligible to receive emergency aid funds will be receiving the quantities detailed in the following table. The left column, Expected Family Contribution (EFC), is refers to the financial need of the student, as determined by the FAFSA, and the other columns correspond to the level of studies and the academic load (Full-Time or Part-Time, according to the number of credits enrolled). Please visit the federal web portal, www.fafsa.ed.gov, to find out your EFC or complete the FAFSA.

Students who have completed the Acceptance Form will receive payment via postal mail to the address that they have registered in the system or through direct deposit in the account that they have registered for such purposes. It is recommended that students who do not have an account registered for direct deposit contact the Treasury Office to complete this process. Those students who have suffered changes in their economic circumstances due to COVID-19 and wish to a review of their EFC should contact the Financial Aid Office.

DISTRIBUTION OF EMERGENCY FUND FOR POST-SECONDARY EDUCATIONAL INSTITUTIONS UNDER THE CRRSAA ACT

Receive a cordial greeting and we pray to God that upon receipt of this statement you and your family are well. The Universidad Central de Bayamón (UCB), received on January 17, 2021 the new allocation of emergency assistance funds for students from post-secondary institutions ("Coronavirus Response and Relief Supplemental Appropriations Act", section 314(a)(1) of the CRRSAA 2021) for eligible students. The amount of aid to be awarded to each student will be subject to the level of study, status (full or part time), as well as the financial need criteria established for the granting of financial aid for Title IV programs. As stipulated in the guidelines submitted by the United States Department of Education (DoE), on June 25, 2020, students must meet the eligibility provisions for financial aid from Title IV programs in order to receive the funds. Section 484 of the Higher Education Act stipulates that a student eligible to receive funds from Title IV programs must:

- Be enroll/enrolled in a degree or certificate program. (Excludes enrolled students who do not have a degree at UCB and those who have withdrawn completely at the time the funds are awarded.)
- Not be enrolled in elementary or secondary school.
- Have satisfactory academic progress. (Excludes students who for any reason did not meet the standard of satisfactory academic progress, Executive Order ADM 14-04 and did not request the appeal process or do not comply with the improvement plan).
- Not be in default on a student loan with funds from Title IV programs and/or have been declared delinquent.
- Have presented, "as part of the verification process of your financial aid application", in the cases in which it applies, a certification that includes:
 - or a statement of educational purpose, at the request of the Department of Education.
 - or the student's SSN card.
- Be a US citizen or national, permanent resident, or other eligible non-citizen. (So it excludes international students who only have a study or companion visa.)
- Have fraudulently returned Title IV funds if convicted by a jury or have entered a guilty plea or no contest.
- Not have fraudulently received loans from Title IV programs that exceed annual or aggregate limits.
- Have repaid Title IV program loan amounts in excess of annual or aggregate limits if inadvertently obtained.
- Have a Selective Service record (in the case of men).
- Have a valid social security number.

- Not have a federal or state conviction for possession or sale of drugs, with certain time limitations.

Receive a cordial greeting and we pray to God that upon receipt of this statement you and your family are well. As we had indicated, the Universidad Central de Bayamón (UCB) was waiting for the United States Department of Education (DoE) to approve and disburse the amount assigned to the institution from the emergency assistance funds for students from institutions post-secondary ("Higher Education Emergency Relief Fund" – HEERF of the CARES ACT) and submit the guidelines on the method in which they should be distributed to students, before proceeding to make the payment of the funds. In addition, we inform you that the amount of aid to be awarded to each student will be subject to the level of study, status (full or part time), as well as the financial need criteria established for the granting of financial aid for Title programs. IV. Yesterday, UCB received the granting of the funds and the approval to make the distribution of the payments and the conditions to carry them out.

As stipulated in the guidelines submitted by the DoE, students must meet the eligibility provisions for financial aid from Title IV programs in order to receive funds. Section 484 of the Higher Education Act stipulates that a student eligible to receive funds from Title IV programs must:
